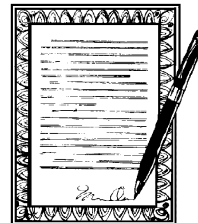

# Lee on The Solent Sailing Club Event Rules



**By signing this entry form, participants accept that: -**

1. Competitors are entirely responsible for their own safety, whether afloat or ashore, and nothing whether in the Notice of Race or Sailing Instructions or anywhere else reduces this responsibility.
2. It is for the Competitors to decide whether their boat is fit to sail in the conditions in which it may find itself. By launching and going to sea, the competitors confirm that the boat is fit for those conditions and that they are competent to sail and compete in them.
3. Nothing done by the organisers can reduce the responsibility of the owners and / or competitors, nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in racing. The organisers encompass every one helping to run the racing and event, and include Lee on the Solent Sailing Club, the organising authority, the race committee, the race officer, patrol boats and beach masters.
4. The provision of patrol boats does not relieve the boat of her responsibilities.
5. The boat is required to hold adequate insurance cover including insurance against third party claims in the sum of at least £2,000,000 (or the equivalent in any other currency).
